pioneer in the field of Composites. In addition to the above EPP Composites is poised for its new growth trajectory with more product solutions for the domestic industries as well as for the export market.


Ease of Doing Business in Gujarat

Gujarat has great vision followed by policy announcements much ahead of other Indian States however the implementation of enabling mechanism is not at same pace which needs rationalization and speedy expedite.

The latest rankings released on September 5, 2020 by Ministry of Commerce shows Gujarat at Rank 10th amongst 36 Indian States .While the ranking is based on the basis of 181 wide ranging parameters but key areas which makes difference in ease of doing business between two states are:

- · Single window system,
- · Inspection enablers,
- · Payment of taxes,
- · Utility permits,
- · Environmental regulations.

However the mechanism to access to 1) information & transparency enablers 2) Labour regulation-enablers and 3) Construction permit enablers. are the Key transactional areas where Gujarat can do better and enhance its position from 10th position
